Together for Albania - International Donors' Conference pledge statement

*Supporting Albania in the post-earthquake recovery
Brussels, 17 February 2020*

On 17 February 2020, the international community gathered in Brussels to collect funds in support of the post-earthquake reconstruction and rehabilitation in Albania. The tables below present the pledges made in the context of this international conference. The pledging was guided by the Post Disaster Needs Assessment (PDNA), which identified EUR 1.076 billion as total recovery needs. The donors raised EUR 1.15 billion. More than EUR 295 million was pledged in the form of grants and EUR 853 million as loans. In addition, EUR 3 million was offered in-kind.

A number of partners were involved as well with the emergency response immediately after the earthquake, with substantial assistance provided during the first days and weeks following the disaster. This assistance is not recorded in the figures pledged below.
